PARN is operating its harm reduction services out of an office at 541 Water Street (see page 3 for more info):

- Mondays, Wednesdays, Thursdays and Fridays from 9:30 am to 4:30 pm and;
- Tuesdays from 11:30 am to 4:30 pm.

In addition to open office-hours, PARN is also providing harm reduction delivery services at the following locations and times:

- Outside of One Roof Community Centre 7 days a week - from 12 pm to 2 pm
- New shelter at the Wellness Centre 7 days a week in the afternoon
- Bethune Street Mondays, Wednesdays and Fridays from 5 pm to 8 pm

Harm Reduction Works now located at 541 Water Street



Spike In Drug Poisonings

Fentanyl is being found in cocaine (both rock and powder) and other drugs. The safest assumption to make right now is that your drugs are poisoned with fentanyl.

Reduce your risk of overdose

- Don't use drugs alone
- When using with a friend, don't use at the same time
- Carry a Naloxone kit and put it in a visible place close to you
- Test your drugs by using a small amount first
- Avoid mixing drugs



Need a Naloxone Kit? We can get you one.

Under Canada's Good Samaritan Drug Overdose Act, you will not be charged for possessing or using drugs for your own use if you seek medical help for yourself or someone else who has overdosed.

Please welcome Sally Goodwin to the PARN Team!

I recently joined the PARN team as a Harm Reduction Outreach Worker and I am excited about the opportunity to work with my colleagues to provide much needed services to some of the most vulnerable people in our community.

Over my first week, I found that people who use drugs are appreciative of PARN's services, particularly at this time when so many services are inaccessible and isolation has been encouraged. I have already had so many genuine and



meaningful conversations with people accessing Harm Reduction services, people who have questions about their drug use, people who want to share their struggles and their successes, and people who are just looking for connection.

I have also had great experiences talking to people who are walking down King Street. The other day, a community member came over to the Harm Reduction Truck to ask what we were doing.

"Harm Reduction," I replied.

The man had never encountered the term before, so I explained using analogies like "you wear a seat belt to reduce the risks of being in a car, and sunscreen when you're out in the sun." And then I explained how Harm Reduction saves lives. His response was profoundly positive, empathetic and understanding. He responded with compassion and proclaimed: "too many people are dying."

We ended up having a lengthy conversation about the poisoned drug supply and how things have gotten worse over the last couple of years, with more folks dying as a result. I stressed how important it is that we all work together to reduce the number of deaths related to opioid poisoning in our community. He expressed that this work is very important and good for the community.

It's this type of compassion and understanding that will make a difference in our community. If you have questions about Harm Reduction, ask us. If you understand harm reduction philosophy and practices, I encourage you to take the time to talk about it with someone who has questions. People are dying in our community, and stigma is contributing to these deaths. We all have a role to play in ending the overdose crisis that has taken so many lives from Peterborough, Northumberland, Haliburton and City of Kawartha Lakes.
